#### Affordable Care Act Orientation and Enrollment Sessions

Individual assistance will be available from 10:00 a.m. to 3:00 p.m. to determine if you're eligible for financial assistance, to create an account on Covered California, and to complete the application for enrollment with the assistance of certified insurance agents and counselors. Applications are now being accepted for the following City grant program:



#### **Fiber Optic Link Project**

This project was constructed to provide a fiber optic link from City Hall to the Brentwood Senior Activities Center and the Brentwood Family Aquatic Center located at Balfour Road and Griffith Lane. This link is to provide a more reliable and faster network service between the facilities. The contractor has completed the project and the link is now fully operational and currently in use. City staff is preparing to bring this item to the City Council in March for acceptance of the project.

One hour orientation sessions to explain the new Health Care Law and answer your questions. In English at 10am and 12pm, in Spanish at 11am and 1pm.


## Enrollment


