BACKGROUND INFORMATION:


The Park and Recreation Commission is an advisory commission to the City Council made up of five (5) Brentwood citizens. The Commission makes recommendations on park and recreation facility designs, use of City parks and recreation facilities, and provides feedback and recommendations in regard to program and facility rules, regulations, policies, and procedures. In addition:

- This Commission meets on the fourth Thursday of each month at 7:00 p.m. in the City Council Chambers.
- Applicants for this Commission must reside within the City limits.
- Park and Recreation Commission Members receive compensation in the amount of \$100 per month.
- One vacancy (One term expiring on 12/31/16)
- Applications must be received by **5:00 p.m. on Friday, December 2, 2016.**

As required by State and local law, all members appointed to the Park and Recreation Commission are required to file a Statement of Economic Interests, Form 700. Items that must be disclosed on the Statement of Economic Interests include: interests in real property located within the City limits, within two miles of the City limits, or within two miles of any land owned or used by the City; and investments and business positions in all business entities and income, including loans, gifts, and travel payments from all sources. This document is a public record subject to disclosure.

Your application can be submitted in person at the City Clerk's office located on the 3rd Floor of City Hall located at 150 City Park Way, or e-mailed to cityclerk@brentwoodca.gov, or via Fax to (925) 516-5441.

In accordance with the Public Records Act, applications and attachments submitted are considered public records and will be disclosed upon receipt of a public records request.
